Position Summary

This position functions to provide instructional leadership in the areas of curriculum development, professional learning, and program development to administrators and teachers regarding best practices, effective instructional strategies, Nevada Academic Content Standards (NVACS), and educational research related to K-8 mathematics. The individual selected for this position will be directly responsible to the Director, K-12 Mathematics, Curriculum and Instruction Division (CID), Academic Unit.

Essential Duties and Responsibilities

The list of Essential Duties and Responsibilities is not exhaustive and may be supplemented.

1. Establish and maintain relationships with administrators at elementary schools, middle schools, high schools, charter schools, colleges and universities, and state and federal agencies.
2. Collaborate with school associate superintendents and/or designee(s) to accomplish Clark County School District goals. Serve as a liaison between the CID and the regions.
3. Collaborate with administrators and project facilitators within and outside the CID on District initiatives.

4. Design, present, facilitate, and coordinate K-8 mathematics professional learning activities for teachers, parents/guardians, administrators, and other audiences, as required.
 5. Supervise preparation of curriculum documents and instructional materials, as assigned. Administer and implement existing grants and their related budgets.
 6. Assist with data collection and grant writing/monitoring.
 7. Facilitate the selection and supervision of teacher task forces for the mathematics curriculum development and revision process, for textbook and instructional materials selection, and for various other curriculum-related projects.
 8. Provide leadership in the development, implementation, and oversight of mathematics curriculum in alignment with District goals.
 9. Seek grant opportunities to support mathematics education; administer and implement grants and budgets.
 10. Gather, evaluate, and disseminate research-based practices in curriculum, instruction, and assessment.
 11. Articulate effective mathematics curriculum, programs, and research to teachers, administrators, parents/guardians, and community members.
 12. Represent the District in matters related to elementary mathematics at the local, state, and national levels.
 13. Collaborate with K-12 mathematics administrators to ensure program alignment.
 14. Supervise and evaluate assigned staff.
 15. Perform other duties related to the position, as assigned.

1. Extensive knowledge of the NVACS in mathematics, including the Standards for Mathematical Practice.
 2. Knowledge of and ability to conduct effective professional learning related to K-8 mathematics.
 3. Knowledge of and ability to use the District's Curriculum Engine.

 5. Effective presentation skills.
 6. Ability to work cooperatively with school and administrative personnel, parents/guardians, peers, and others.
 7. Ability to write, analyze, and edit curriculum documents and resources.
 8. Current knowledge of state and local K-8 student assessments.
 9. High level of self-confidence, initiative, self-direction, and motivation.
 10. High-level skills in planning, organizing, and coordinating job-related tasks.

Must possess or be able to acquire by time of appointment to the position, a Nevada school administrative endorsement.

Experience

1. Have previously demonstrated at least five (5) years of successful licensed elementary classroom and/or middle school mathematics teaching experience in an accredited K-12 public or private school and be able to acquire, by time of appointment to the position, a Nevada administrative endorsement **(or)** have previously demonstrated at least three (3) years of successful licensed elementary classroom and/or middle school mathematics teaching experience in an accredited K-12 public or private school and currently hold a valid Nevada administrative endorsement.
2. Evidence of successful teaching experience in K-8 mathematics.
3. Present or previous successful experience in a mathematics teacher leadership position.
4. Experience in conducting professional learning related to K-8 mathematics.

Preferred Qualifications

1. Coursework in advanced mathematics.
2. Experience in program management.
