Position Summary

This position is responsible for the operation of the Clark County School District (CCSD)'s networking systems. This position also serves as consultant and liaison to CCSD and other divisions and entities for information on networking, emerging technologies [i.e., Internet, WWW, Telecommunications, server administration, local area network (LAN) and wide-area network (WAN)] and their application within CCSD for the Networking Services Department. This position is directly responsible to the Director III of Networking Services, Technology and Information Systems Services (TISS), Operational Services Unit (OSU).

Essential Duties and Responsibilities

The list of Essential Duties and Responsibilities is not exhaustive and may be supplemented.

- Oversees the installation and ongoing maintenance of CCSD's WAN and LAN data network.
- 2. Implements and manages a system for the systematic upgrading of facilities and software necessary in providing Networking Services.
- 3. Implements and manages a system for allowing the research of emerging technologies and their application.

- 4. Develops and implements procedures for documentation of network operational procedures and system configurations.
- 5. Formulates and develops CCSD's network disaster recovery procedures and plans.
- 6. Tests, develops, and implements emerging technologies and delivery methods (Broadband Access Technologies, fiber, cable, etc.) to integrate select technologies into existing telecommunications systems.
- 7. Provides direction and supervision to the personnel operating the technical infrastructure for Networking Services.
- 8. Plans the operating budget for Networking Services and emerging technology research.
- Provides and coordinates consultant services for CCSD divisions, central office administrators, and others on emerging technologies, networking, and telecommunications districtwide.
- 10. Tests, develops, and implements network systems for use in an instructional/educational setting.
- 11. Performs other duties related to the position, as assigned.

- 1. Ability to communicate clearly in both verbal and written communications.
- 2. Ability to work cooperatively with school, technology services, and administrative personnel.
- 3. Ability to utilize and promote the use of participatory management techniques.
- 4. General knowledge of technology as applied in a school setting.

- 7. Ability to direct multiple major projects and initiatives.
